

CODES OF CONDUCT.

Simon Says Dance aims to promote an inclusive, supportive and happy environment for children, young people and adults alike. We therefore expect everyone follow these principles and procedures to ensure this desired environment is maintained.

STUDENTS:

We expect SSD students to follow and adhere to the following principles whilst at Simon Says Dance or attending any SSD offering. If SSD determine any breach of the below to be of a serious nature e.g bullying - students will be suspended from attending SSD with immediate effect. **Students therefore must:**

- Wear suitable clothing for dancing
- Bring at least a bottle of water to any SSD Classes or offerings
- Make SSD a FUN place to be - for everyone!
- Give any SSD Class or offering 100% effort
- Practise any material at home if required (for shows etc.)
- Be loyal and give friends a second chance
- Be friendly and welcoming especially to new students/participants
- Be supportive and loyal to other students/participants
- Always include everyone and do not isolate anyone
- During SSD games & activities: play fairly and respect winners if you lose
- Take care of any equipment/belongings that do not belong to you
- Respect all peers, adults and SSD staff regardless of: age, gender, ability, race, cultural background, religious beliefs or sexual orientation/identity
- Respect the instructions and decisions of adults and SSD Staff
- Help those who are sad or distressed
- Report inappropriate behaviour immediately to an adult, DCPO (Designated Child Protection Officer - Simon Hunter) or SSD Staff
- Not use phones during teaching
- Not bully, make inappropriate remarks, be violent or aggressive to anyone - this includes any of these actions over the internet/online
- Not leave any premises during a class without adult or staff permission
- Not use bad language
- Not get involved in inappropriate peer pressure or pressure anyone else
- Not inappropriately disrupt any SSD Class or offering
- Not smoke or consume any alcohol or drugs at any class venue or whilst representing SSD and/or SSD offerings

STUDENTS HAVE A RIGHT TO:

- Be safe and happy in their chosen activity
- Be listened to
- Be respected and treated fairly
- Privacy
- Enjoy SSD in a protective environment (within reasonable control)
- Be referred to professional services for help if needed
- Be supported regardless of personal background
- Be protected from abuse by other SSD students/members or outside sources as per the SSD Safeguarding & Child Protection Policy
- Participate on an equal basis, appropriate to their ability
- Experience competition and the desire to win
- Be believed
- Ask for help
- Have any concerns taken seriously and acted on



Students are responsible for reporting any incident if unnoticed by an adult or member of SSD staff. SSD will not force any student to speak up or report anything they do not feel comfortable reporting - in such cases, SSD have the right to refer to professional services for advice. SSD will always aim to involve parents/guardians in any such process as advised by any appropriate professional service.



PARENTS, IT'S YOUR TURN

PARENTS/GUARDIANS:

Parents/Legal Guardians play a pivotal role in the development of their child through encouragement, belief and support. To ensure students get the maximum from SSD classes and/or offerings, we ask all parents/legal guardians to follow these principles. **As parents/guardians, you are expected to:**

- Positively reinforce your child & show interest in their chosen activity
- Do not push them into activities they do not want to do
- Detail all medical information during registration
- Inform any changes in medical info to SSD immediately
- Ensure that contact details are always up to date
- Ensure our 'Terms & Conditions' have been read - T&C's are automatically agreed to if a child is enrolled to a SSD class
- Adhere to all SSD policies/conditions on our website
- Be on time for drop-off and collection
- Always remain on-site of any SSD Class or offering within permitted areas if you wish to supervise your child (this is recommended)
- Only leave the site of any SSD Class or offering if you believe your child is able to care* for their self for the duration
- Inform SSD staff if your child is to be collected early or by another responsible adult
- Ensure your child has the correct clothing and refreshments at class
- Inform SSD immediately if your child has any contagious illness and refrain from allowing your child to attend any offerings until well again
- Ensure your child always wears appropriate footwear
- Ensure that your child understands their code of conduct above
- Encourage your child to play by the rules
- Behave responsibly during any class, offering or show
- Be respectful to other parents
- Be realistic & supportive - teach them that they can only do their best
- Accept and respect the decisions/instruction of SSD staff
- Be patient and supportive with any sign-in and sign-out procedure in place at any SSD class, offering or show
- Inform SSD if your child will not be returning to class
- Be aware that it is sometimes necessary for instructors to professionally use physical contact for the purposes of movement and posture improvement/instruction
- Discuss any concerns or queries with a member of SSD staff only

*Care relates to the child's ability to attend the toilet facilities on their own. SSD staff will always ensure the safety of the children whilst on-site however the primary care and supervision remains the responsibility of the child's parent/legal guardian at all times. SSD Instructors will only supervise the activity being carried out to ensure it is done so appropriately and safely. SSD do not take any responsibility for the failure to make classes or collect on time due to SSDHQ car park congestion and parents should plan their journeys to account for any traffic or congestion at SSDHQ and en-route.

PARENTS/GUARDIANS HAVE A RIGHT TO:

- Be assured that your child is safeguarded as per the SSD Safeguarding & Child Protection Policy during their participation
- Be informed of problems or concerns relating to your children
- Be informed immediately if your child is injured
- Know that your child's instructor is registered on the PVG Scheme
- Discuss any specific requirements etc. with a member of SSD staff
- Have your consent sought in advance for: trips, photography and any other activity or action carried out in relation to Simon Says Dance
- Contribute as you see fit and volunteer only if you wish
- Have any concerns about any aspect of your child's welfare listened to responded to



STAFF, IT'S YOUR TURN

STAFF/SUB-CONTRACTORS/VOLUNTEERS

SSD staff or any helpers/volunteers are effectively role models for each and every child or adult who attends any class or offering. It is therefore essential that the following principles are followed to ensure not only the safety of students but the development and progression of students also. **Staff are therefore expected to:**

- Ensure the safety of all children by providing effective activity supervision* during class
- Pre-plan classes and/or activities appropriately
- Make the class/offering FUN!
- Consider the well-being and safety of participants at all times
- Be a role model, displaying a consistently high standard of behaviour and appearance
- Be disciplined, committed and timely
- Take time to explain routines/techniques
- Respect and listen to the opinions of students
- Encourage and guide participants to accept responsibility for their own performance and behaviour whilst attending SSD
- Treat all young people fairly and ensure they feel valued
- Be positive, approachable and offer praise at all times
- Promote team work to stimulate collaboration between students
- Encourage all children not to discriminate on any grounds including: religious beliefs, race, gender, social classes or lack of ability
- Ensure the rights and responsibilities of students are enforced as highlighted above within the 'Students' Code of Conduct
- Administer first aid appropriately - if you are not trained to carry out any first aid action, you must inform a trained first aider immediately. For 'serious' injuries, staff must always call an ambulance immediately
- Have access to a telephone/mobile phone for immediate contact to emergency contacts/services if required
- Only make medical decisions if a student's parent/legal guardian/emergency contact is not immediately on-site or available
- Assume consent to provide first aid (if trained) to any child, young person or adult who is unconscious or unresponsive
- Maintain confidentiality about sensitive information (unless such information is detrimental to the well-being of the student)
- Not abuse members on any level
- Not engage in any relationship with any young person attending classes or offerings
- Report Incidents (including abuse) and accidents to management of Simon Says Dance, who must take record and involve any professional service as necessary using the SSD Safeguarding and Child Protection Policy
- Not allow any rough or dangerous play, bullying, or the use of bad language or inappropriate behaviour
- Never use sanctions that humiliate or harm young people
- Never condone rule violations, rough play or the use of prohibited substances
- Refrain from smoking and consumption of alcohol during classes or offerings
- Hold appropriate and valid qualifications ie. Public Liability Insurance or any other relevant insurance policy specific to their activity, First-Aid Certification and be registered on the PVG Scheme

*Supervision refers only to the activities carried out within the studio/room being used. As SSD is an activity provider and not a day-care service, we do not provide personal care and will only supervise on a professional level to ensure activities are carried out safely and appropriately. Care supervision is the responsibility of the parent/legal guardian - who are advised to remain on any site that SSD operates to provide any immediate care provided if their child is not able to, for example: taking themselves to the toilet.

STAFF/SUB-CONTRACTORS/VOLUNTEERS HAVE A RIGHT TO:

- Work within a safe, fun and supportive environment
- Receive support in any circumstances but especially if reporting suspected abuse or poor practice
- Access to available professional support services
- Fair and equitable treatment by Simon Says Dance management
- Discuss any issues/concerns or queries directly related to Simon Says Dance with Simon Says Dance management
- Be protected from abuse by students, other staff and/or parents
- Not to be left vulnerable when working with children
- Appropriately exclude students from activities especially if a student is jeopardising the safety and/or well-being of any staff and/or students
- Report inappropriate behaviour to parents
- Request that a repeatedly disruptive student is removed from a class or offering

The SSD Code of Conduct Policy will be reviewed regularly and updated as necessary.
